### **Quebec Coroner slammed by former witness**

*Montreal Quebec, November 15<sup>th</sup>, 2017:*

Luc Malouin got it totally wrong.

#### **Eloise Dupuis and Mirlande Cadet were murdered!**

They didn't stand a chance! Did he do any research? Did he talk to any of the thousands of families who have lost loved ones because of this religion?

Obviously not!

I read the comments of Luc Malouin. It is all bullshit. Jehovah Witnesses have been bleeding to death in this country for about 70 years. What is Plan B?

There is no Plan B. There probably will never be a Plan B....Not as long as the establishment runs this country. I think it is time for Luc Malouin and his buddies to retire. For seventy years the establishment has ignored this issue with countless victims.

#### **How many more Jehovah's Witnesses have to bleed to death?**

Eloise Dupuis and Mirlande Cadet were not capable of making an informed decision.

Years of intense indoctrination, attending five or more meetings a week, coupled with undue influence, brainwashing and coercion, robs a Jehovah witness of free choice. Also, the information in the publications used by the Jehovah's Witnesses to educate their members is often false, misleading and hinders an informed refusal.

The church says if you get a blood transfusion, you will get AIDS or the soul of the person who donated the blood. If that person was crazy, you'll go crazy. If that person was homosexual, you'll be a homosexual.

When you're given all this misinformation, how can you make an informed decision?

The combined result of misinformation and coercion, I believe is a form of mind control. If you control the mind.....you control the person. That is how a parent could sit there and watch their child bleed to death and do nothing about it. That totally goes against instinct. Even wild animals protect their young. So for a parent to allow their child to bleed to death, and do nothing to save the child, that shows the power this religion has on people.

Any member of the church who willingly accepts a blood transfusion would be disfellowshipped and shunned by their Jehovah Witness family and friends.

Jehovah Witnesses are not allowed to have any friends outside of the religion.

I was made to sign a document declaring I would refuse blood transfusions in front of two elders. If you don't sign that card, you're in big trouble. The elders would have a meeting with you and try to adjust your thinking. They use those exact words – 'adjust your thinking'.

Members with too many questions are "disfellowshipped".

I was a Jehovah Witness for twenty years. My sixteen year old daughter was diagnosed with leukemia. There was a constant flow of Jehovah Witnesses, all

encouraging her to be faithful and to not accept a blood transfusion. HLC members in collaboration with the family and elders fill the patients room to prevent any non JW from entering . I have heard where the church elders guarding the patient used physical force.

My sixteen year old daughter received hundreds of cards and letters from church members, encouraging her to be faithful and to refuse a blood transfusion.

Bethany told me that her lawyer promised her that she would be featured in the **Awake** magazine, if she died for her faith. Members who have died refusing a blood transfusion are featured in the **Awake** magazine. According to Religious experts, the Watchtower Society practices **Martyrology**. Having one person sacrificed is a tragedy. No one should have to die for a religion.

In my daughter's case, the HLC member was not helpful but created friction with the medical staff and made things more difficult.

The lawyer informed us that a plan was in place to sneak Bethany out of the hospital and hide her at the Watchtower Society headquarters. The lawyer is a member of a secret religious order called "**Bethelites**".

The "**Bethelites**" work and live at the Watchtower Society headquarters. Imagine the lawyer is sitting in the patients room. That would be the same as if a Cardinal from the Vatican was in the room of a catholic. That alone would be influence enough for a sick church member, when it is crystal clear that a blood transfusion is **not an option**.

My daughter asked the Child Psychologist why her lawyer was pressuring her to physically resist the treatments. Bethany was being told by her lawyer that the chemotherapy and blood transfusions would not help her and was not required for her to live. Bethany was being told that if she refused medical treatment, she would not die. Bethany was being given misinformation concerning medical treatments , almost on a daily basis. The truth was being withheld from her.

The HLC moves my daughter to a secret location in another city. The WTS lawyer arranges for my daughter to be fed arsenic. Bethany died a short time later. I did not know where they had hidden her. I was not allowed to visit my dieing daughter or to tell her how much I loved her.

**In hospitals all over the world, Jehovah Witnesses are bleeding to death.**

This is sick. This is evil. This has to STOP! When will this insanity end? I call this "**Institutional Murder**".

I approved of the blood transfusions for my daughter. I knew that when I did so, I was going to lose my family, but I wanted my daughter to have a chance to live. My three daughters shunned me. My wife shunned me. All Jehovah's Witnesses shunned me. No one would talk to me. They pretended like I was not there....like I didn't exist. I was like a ghost.

That is what happens a lot of time with Jehovah's Witnesses who go up against the church. They have lost everyone and they are all alone, as I was all alone.

I have been told by strangers that my daughter is married and has children.

The laws of informed consent need to be changed. The Quebec Civil Code needs to be reformed to allow medical staff to administer life saving treatment in situations where free informed consent is in serious doubt.

There should be a Federal Investigation into the conduct of WTS officials and criminal charges laid .
